Applications will not be processed unless all applicable sections have been completed and payment is received.

Note: This form is only to be used by youth-age players who are/were registered with a senior team who wish to return to a youth club team.

Application for Reinstatement to Youth Status Procedures.

1. A player requesting a reinstatement to youth status must complete section one (1). If the player is currently registered with a Senior Team, complete transfer information in Section 1 and forward to the releasing Team Official. If not currently registered (i.e. player had player for a senior team the previous season) leave Section 2, 3 & 4 blank and forward to your home district official
2. If applicable, the releasing Senior team official must complete and sign section two (2) in its entirety before forwarding application to the League for release
3. If applicable, the releasing league official must complete section three (3) before forwarding application to the team receiving the player for acceptance.
4. If applicable, the accepting team official must complete section four(4) before forwarding the application to the Youth District for approval
5. The Accepting District must complete section four (4) before forwarding to the BC Soccer Association for approval with payment in the amount of **\$25.00**.
6. Applications will not be processed until full payment is received and application has been completed in full.
7. The player is not eligible to play until the application has been approved by BCSEA.

BC Soccer Rules and Regulations pertaining to the Reinstatement of players

RULE 9. REINSTATEMENTS

- a) Any registered senior player of youth age wishing to be reinstated to youth status must apply to the Association to be reinstated on forms supplied by the Association.
- b) The Association shall have the authority to approve or deny a player's application for reinstatement.
- c) Reinstatement of senior players to youth status may be granted by the Association prior to January 15th of the current coastal playing season and prior to June 30th of the current interior playing season.
- d) A player may only be reinstated to youth status once per season.
- e) The reinstatement fee, per application, shall be determined and circulated by the Association prior to March 15th annually, in advance of the forthcoming season.
- f) Reinstatement fees are non-refundable.
- g) A registered senior player, after being reinstated to a youth team, must wait a period of seven (7) days before taking part in any game for the youth team. The seven-day period commences from the date the completed reinstatement application and fee are filed with the Association.
- h) No youth team shall be allowed to register more than three reinstated players in one season.

Note: The player, requesting reinstatement, must be in full compliance with the Rules and Regulations of the BC Soccer Association.
