## **Application to Transfer - Youth to Senior Procedures.**

1. A youth player requesting a transfer to a senior team must complete section one (1) in its entirety before application can be brought forward to the releasing Team Official.
2. The releasing youth team official must complete and sign section two (2) in its entirety before forwarding application to the district .
3. The releasing district official must complete section three (3) before forwarding application to the senior team receiving the player for acceptance.
4. The accepting senior team must complete section four (4) before forwarding application to the Accepting League for approval.
5. The Accepting senior league must complete section five (5) before forwarding to the BC Soccer Association for approval with payment in the amount of **\$10.00**.
6. Applications will not be processed until full payment is received and application has been completed in full.
7. Players are not eligible to play for the senior team until the transfer has been approved by BCSEA.

## **BC Soccer Rules and Regulations pertaining to Youth to Senior Transfers**

### **RULE 8. YOUTH TO SENIOR TRANSFERS**

- a) Any registered youth player wishing to transfer services to a senior team during the current playing season must do so on forms supplied by the Association.
- b) No youth to senior transfers will be permitted after the dates outlined in paragraph "b", Rule 7 - Transfer of Players.
- c) Transfer fees are subject to regulations as defined in paragraph "k", Rule 7 - Transfer of Players.
- d) Youth to senior transfer fees are non-refundable.
- e) A youth-aged player who has been registered as "senior amateur" shall be ineligible to play in any youth club competitions unless said player has upon request, been reinstated to youth status by the Association.

### **RULE 7. TRANSFER OF PLAYERS (partial)**

- b) A player is entitled to a transfer as hereinafter provided, by January 15th of the current year for the coastal/winter playing season and by June 30th of the current year for the interior/summer playing season. A player shall not be allowed to transfer during the team's playing season without the consent of the team for which the player is registered. A player currently under suspension and seeking a transfer is not eligible to play until the suspension has been served.
- k) All transfers shall be subject to a transfer fee, to be determined and circulated by the Board, prior to March 15th annually, in advance of the forthcoming season, due and payable to the Association, before the transfer can be completed.
